

Tariff VN shall apply for the making of audiovisual productions. In certain cases, it is possible to licence the making available together with the reproduction licence. In such cases, the one-off licence fee per film and web presence (own domains) shall be:

Stream: CHF 100.00
 Download: CHF 200.00

The audiovisual production can also be made available on all social media against payment of a blanket fee of CHF 150.00. Please note that we have no influence on the General Terms & Conditions of the social media.

This blanket option can, however, only be chosen for the applicants' **own audiovisual productions and does not apply to advertising campaigns.**

In all other cases, the following terms and conditions shall apply; they are also valid for audio streams:
